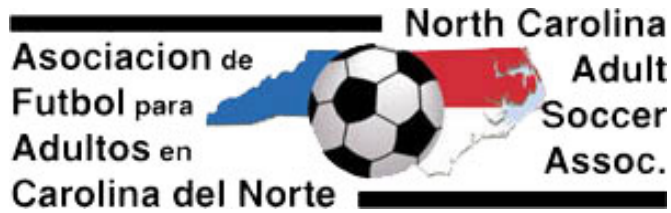

## Election of NCASA Officers: 2009 Nomination Form

### Summary of Election Process & Officer Positions

#### ARTICLE II Section 3

The election of officers will take place at the Annual General Council Meeting (AGM). Officers will take office on the day after their election. They may succeed themselves in office. Their terms of office will be:

President – 2 years	Executive Vice-President – 2 years
Regional Vice-Pres./East – 2 years	Regional Vice-President/West – 2 years
Secretary – 2 years	Treasurer – 2 years
Registrar – 2 years	Discipline & Appeals Chair – 2 years

Elected in **odd** numbered years: President, Regional Vice-President/East, Secretary and Registrar.

Elected in **even** numbered years: Executive Vice-President, Regional Vice President/West, Treasurer and Discipline and Appeals Chairman.

To be elected to office it shall be necessary to receive a majority of the votes cast. Nominees must be in good standing.

### Summary of Nomination Process

#### ARTICLE II Sections 4 & 5

S4 At least sixty (60) days before the election, the Association President shall appoint a Nominating Committee with the advice and consent of the Executive Committee. It shall consist of a chairman and four other members.

Names and addresses of the members of this committee will be given to the delegates when they are notified of the Annual General Meeting.

S5 The Secretary will notify all Council members of the slate of officers submitted by the nominating committee ten (10) days before the election.
