#### **NEW BUSINESS:**

Updated 13U G/B NLPC Fall Playoff guidelines:

In reference to the 13U Girls/Boys teams who participate in NCYSA's 13U G/B Fall NLPC Playoff for a chance to earn one of the 4 Spring 13U NLPC league play slots for NC:

- Addition of verbiage to guidelines:

*"Teams participating in the NCYSA 13U Girls/Boys Fall NLPC Playoff: those Spring NLPC (13U) slots earned from these participating teams/clubs must utilize 75% of the rostered players from the team who earned the slot via that NCYSA 13U G/B Fall playoff."*

Updated NCYSA National League-Piedmont Conference (NLPC) Nomination Criteria:

- 1) Update NLPC Nomination criteria to directly include within the document the understood adoption of the Classic Handbook's "Club Ownership of Slots"
- 2) Addition of "Club Continuity of Returning Players" for slots earned by teams participating or seeking to participate in the NLPC. See attached form.

At all times during the upcoming seasonal year, a slot earned by an NCYSA club per the NCYSA NLPC Nomination Criteria, must have on its NLPC roster, to be eligible to play during that upcoming seasonal year, no less than 9 of the players that were on a roster of any properly registered US Youth Soccer team within such team’s Club during the previous seasonal year (year when the slot was earned per the NCYSA NLPC Nomination Criteria.”
